The Institute became AACSB member in 2014 and is currently in the process of achieving international accreditation from AACSB. As a part of AACSB implementation, the iSER and iSER update report has been accepted by Initial Accreditation Committee in 2016 and 2017, respectively. The Institute has also introduced Assurance of Learning (AOL) management system ensuring that the students achieve learning expectations from the learning goals defined under various programmes.

# Research Studies Undertaken by IIFT (2017)

### Preparation of Export Management & Compliance Manual for Hindustan Petroleum Corporation Ltd. (HPCL)

This study has undertaken development of Export Management and Compliance Manual and is aimed at mapping-out the HPCL export compliance strategy so as to provide the standardized guidance to all employees/ stakeholders to manage the firm's export operations systematically.

#### Short-study on Challenges and Strategies to Promote India as a Sourcing Destination

The study sponsored by Ministry of Textiles examined some major product segments in the textile sector including apparel, carpets, cotton and man-made fibre. A select group of buying houses and exporters of each product category located in various parts of India were contacted to understand the challenges faced with respect to quality, delivery, pricing and compliances. Based on the survey, detailed recommendations were given to overcome some of the major challenges. It was presented in the Textiles India 2017 conference at Gandhi Nagar, Gujarat.

#### Development of Marketing Strategy for Promotion of Handloom Exports

Given the high employment opportunity of the handloom sector and the contribution of handlooms to India's cloth production as well as exports, a study on promoting the handloom exports from India becomes imperative. The present research study is carried out to understand the major items of handloom exported from India, the major markets to which these are exported, and opportunities and challenges for Indian handloom exports. The outcomes of the study have been used to help devise a marketing strategy for promotion of handloom exports from India. The Study was sponsored by Handloom Export Promotion Council, Chennai.

### Development of Export Promotion Strategy for Nagaland

In order to promote India's exports on sustained basis, it becomes important to involve the states with

specific focus products with existing foreign demand. The main objective of the study is to develop an export promotion strategy envisaged to act as a catalyst to promote India's exports on a sustained basis from the State of Nagaland. Department of Industry and Commerce, Government of Nagaland has sponsored the study.

#### Study on Effects of International Trade Scenarios of Indian Copper Industry

The study aims to assess the effects of the international trade scenario on the Indian copper industry. It proposes to analyze both quantitative trade data and qualitative information through survey. It would analyze the issues pertaining to the domestic industry in the presence of international trade. This involves an assessment of the factors relating to the increased imports of copper products (free trade agreements, subsidies given by foreign countries) and its effects on the domestic industry. It would also analyze the trends in exports of copper products from India and factors inhibiting the growth in exports. The study would then analyze the prevalent inverted duty structure in the copper industry and the need for suitable measures. Finally, it would make some recommendations for the industry considering both export and import scenario. The Study has been sponsored by Indian Primary Copper Producers Association (IPCPA).

#### Exploratory Study on Linkages between Technology and Trade

The study sponsored by Department of Science and Technology aims to analyze international trade patterns of Indian exports and imports classified at varying level of technology intensity and develop linkages between trade performance and technology competitiveness with its possible implications. It will explore the direct and indirect aspects of this phenomenon to help policy-makers develop insights on the development of S&T for enhancing contribution of Indian trade in global value chains.
